# Listing Agreement

- In the event of non-payment by the Seller of any commission due by this agreement, the Seller shall be liable to East Shore Yacht Brokerage for any attorney's fees or collection costs associated with collecting said commission.
- It is understood and agreed that East Shore Yacht Brokerage has exclusive sales rights for the above named vessel. I herewith agree to notify and refer all parties over to East Shore Yacht Brokerage immediately upon any offer or contact with individual or brokerage firm.
- In the case of a sale or exchange made within one hundred-twenty (120) days after the termination of this listing agreement to parties with whom East Shore Yacht Brokerage negotiated, or showed the above named vessel to, during the life of the agreement. I agree to pay East Shore Yacht Brokerage a full commission often percent (10%) of the gross sale price. In case a deposit is forfeited, one half shall be deemed payable to East Shore Yacht Brokerage and one half shall be payable to the Seller.
- It is understood and agreed that East Shore Yacht Brokerage will exert its best effort in the promotion of the sale of the subject vessel. Seller agrees that the statements and representations contained herein are a part of this listing agreement.
- It is understood and agreed that the Seller will be responsible for maintaining hull and liability insurance coverage on the vessel during the term of this agreement.
- It is also understood that all details submitted on the separate vessel information sheet are true. Any discrepancies that may affect a completed sale will make the Seller responsible to the Broker any commissions that may be due.
- This Agreement contains the entire agreement and represents all prior agreements and understanding, oral or written, between the parties.
