This agreement only allows High & Dry for the vessel described above. If the customer desires to store/use a vessel other than referenced above, the customer must complete a new agreement and provide the necessary supporting documents for the vessel before it is brought on premises. If ownership of the vessel is transferred to another party, there is a \$100 administrative fee for transfer of contract. The new owner must present all requested documents to East Shore Marine (ESM) before a transfer can be authorized. Refunds will not be provided for any reason. All costs must be paid in full accompanied by this signed agreement, driver's license, vessel registration, and proof of minimum insurance requirements (*see below) by May 1st or the spot will be made available to another party.

**Insurance Requirements: A minimum of \$250,000 is required for property damage and general liability. Anchorage Yacht Club and East Shore Marine must be listed as "additionally insured" or "interested party". A fine of \$25.00 a day will be incurred for each day a vessel does not have the required insurance. _____*

- Hours of operation: Monday – Friday 8:00 AM – 5:00 PM Saturday, Sunday, & Holidays 9:00 AM – 5:00 PM. End-of-Season (October/November) Sunday launches must be reserved by Saturday at 3:00 PM.
- 1 hour lead time required.
- Each customer is allotted one launch and haul per day.
- You are entitled to one trailer lift and load per year. Additional moves can be provided at \$15/foot
- High & Dry Season is from May 1st – October 31st. Launches and hauls outside of those dates can be provided for a fee.
- The service is for personal use only. Sub-letting or renting of vessels is not permitted and will result in immediate cancellation of service without a refund. _____
- ESM is not responsible for any damage caused by flushing engines. _____
- High & Dry Service does NOT include any maintenance or winterization services.
- Customers and outside vendors are not permitted to maintain, repair, or detail vessels on ESM property. If customers choose to use an outside vendor, the vessel must be transported elsewhere to do so. _____
- There will be absolutely no fueling, bilge discharge, or dumping of any sort at the dock. If these services are required, a qualified technician must be hired at the renter's expense.
- Trailers are not permitted on ESM or AYC property. All trailers are to be taken off the premises the same day.
- Yacht Club amenities are NOT included in this agreement. Restrooms for High & Dry customers are located behind East Shore Marine.
- You will receive one parking sticker. All guests must show ID to enter AYC.
- Lessee acknowledges that unforeseeable and uncontrollable risks exist when docking their vessel and storing on land such as tides, winds, foul weather, theft, fire, or any acts of God. The Lessee agrees that East Shore Marine and the Anchorage Yacht Club are not responsible for any damage that occurs as a result.
